

# Erasmus+

## Introduction

Erasmus+ is the EU Programme in the fields of education, training, youth and sport for the period 2014-2020. The Erasmus+ Programme can provide funding for a variety of activities relating to lifelong learning. This includes the possibility of receiving funding to attend teacher training courses at Anglo-Continental.

The European Commission is responsible for the running of the Erasmus+ Programme. The implementation of the Erasmus+ Programme is mainly carried out by National Agencies in each of the Programme Countries.

## Who can apply for funding?

Individuals can only apply for funding via an organisation, such as their university or school. This institution can submit an application form to the European Commission requesting Erasmus+ funding for their staff. If the project is selected, the institution will become a beneficiary of an Erasmus+ grant.

#### How to apply for funding

To apply for funding to attend a teacher training course at Anglo-Continental, institutions should complete an application form under Key Action 1: Mobility of individuals.

Applicants have to submit their grant application by 1 February at 12:00 (midday Brussels time) for projects starting between 1 June and 31 December of the same year. Projects starting later in the year will have a later application deadline. Your institution should register on the European Commission's Participant Portal website and receive a Participant Identification Code (PIC).
